A) Prescribed Qualification, Eligibility criteria, Age-limits

1. The candidate must possess requisite qualification as listed in the above table as on cut-off date.
2. The candidates who have passed ITI in 2022 and prior to the year 2022 will have to produce an affidavit on non-judicial stamp paper sworn-in before a Magistrate or Notary Public to the effect that they have neither undergone apprenticeship training from anywhere earlier nor have taken employment anywhere.

3. The age of the candidate should be maximum 21 years as on cut-off date. A relaxation of 5 years is admissible for SC/ST candidates and 3 years for OBC candidates in the upper age limit. All govt. guidelines on the matter will be observed.

B) Period of Apprenticeship training – As indicated against respective trades.

C) Stipend - As admissible under the rules.

D) Selection Methodology – The candidates will be selected on the basis of written test (subject knowledge) to be held at Taloja Copper Project. If two or more candidates secure equal marks while preparing merit list, then the candidate of higher age will be considered. Preference will be given to candidates from Maharashtra. Candidates called for Written Test have to make their own arrangements. Company does not have accommodation facility.

E) How to Apply

1. Candidates are advised to carefully read the full advertisement for details of educational qualifications and other eligibility criteria before submission of online application.

2. Candidates should register themselves for apprenticeship in Government of India portal (www.apprenticeship.gov.in). The unique number generated on this website must be entered in the appropriate column in the Application format.

3. The Applications as per format below complete in all respect along with copies of certificates/documents with original & 2 extra passport size photograph self-attested should be submitted through Speed Post/Regd AD in the Office of Junior Manager (HR), Hindustan Copper Limited, Taloja Copper Project, E33-36, MIDC, Taloja – 410208 latest by **12/07/2024**.

F) General Instructions

i. The candidate is advised to submit the Applications well in advance without waiting for the closing date.

ii. Candidates shall ensure that Application form is neatly filled and all the documents are attached. Application with incomplete information and/or not accompanied with following documents are liable to be rejected and no correspondence in this regard will be entertained.

a) True copies of all certificates/mark sheets/testimonials regarding age, qualifications, caste.

b) Candidates who have passed prior to the year 2022, they should attach an Affidavit on Non-judicial stamp paper duly attested by Magistrate or Notary Public to the effect that they have neither undergone Apprenticeship Training earlier nor have taken employment anywhere

d) Candidates should register themselves through the website www.apprenticeship.gov.in and submit the registration ID proof.

iii. **Candidates are advised to keep their e-mail Ids and mobile numbers active till the completion of this engagement process. All correspondences will be made to the e-mail Ids as mentioned by the candidates in their application form.**

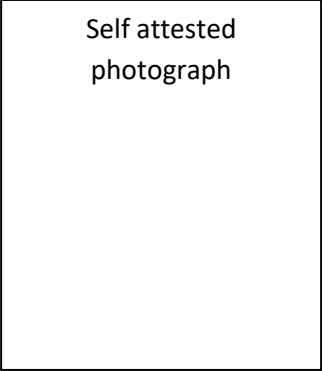
